OLD BUSINESS:

Design Review Committee Update:

This month there was a application for a Shed and Solar panels. Over all it has been a pretty slow month according to Ms. Sara Howard the District Covenant enforcement person. Thus far in 2023 there have been a total of 16 applications.

Covenant enforcement:

Difficult to get cooperations of Property owners but rentals are more even more difficult. Send a copy to property management company/owner and Renter. Sentry Drive two properties. Weeds are out of control throughout the district. Ms. Howard reported there were 80 yard violations. Ms. Howard reported that more fines are being paid. Past due invoices are being sent. Landscaping is a continuous violation. Ms. Howard pointed out that her invoices denote the calls she has made. Owners want to see pictures which Ms. Howard provides. Trash cans are typically repetitious, however there has been a big improvement with trash cans being left out. Weeds are higher thanks to a rainy May and June. Also, Ms. Howard reported there appears to be two abandoned vehicles in the district.

NEW BUSINESS:

Trail repair. We maintain the trail to keep it weed free but we do not do repairs according to President Wherry. Mr. Wherry stated that the City should repair the gravel trail that was washed out. President Wherry asked When will Timberline they remove dead plants on Squirrel Creek Road. Mr. McGrady will as Mr. Hauser. There is a buckled sidewalk at 7975 Campground.

Perhaps Cumberland Green can look at concrete shaving on Stormwater Catch basins as they pose a trip hazard. Mr. McGrady pointed out that the storm water inlets belong to the City of Fountain and the sidewalks typically belong to the homeowner.
