The Cumberland Green Metropolitan District is 265.70 acre development that is located approximately 16 miles Southeast of Colorado Springs and is located within the City of Fountain, Colorado. The District was created on December 14, 2005 and provides the following services under its approved Service Plan:

- · Parks and Open Space Maintenance
- Covenant Enforcement
- · Payment of General Obligation Debt

The District imposes a 47 mill tax levy. The money derived from the District's mill levy is used to service its \$5,380,000 General Obligation Debt, maintain the District's parks and open space, enforce of the community covenants, and pay for various administrative expenses.

The community has approximately 577 single homes and is currently considered built out.

The District's current assessed valuation is approximately \$17,628,570 which is sufficient to support the District's \$569,811 annual budget.

Spring! As the saying goes, "April showers bring May flowers!" But our enthusiasm can be short lived when it seems, like overnight, weeds of all kinds are sprouting up in lawns, rocks, and driveways, and winter kill has attacked our lawns that were green last summer!

Cumberland Green Metropolitan District is not an HOA but rather a Special District governed by Colorado Revised Statute Title 32. One of the services Cumberland Green Metro provides is code enforcement. The Master Covenants were executed in 2006, and the Guidelines and Rules and Regulations are a short version of those covenants. Both documents can be printed off the District's website by going to www.cumberlandgreenmetro.org.

Landscaping violations cover a wide range of infractions including:



- No grass or dead grass (in patches or entire lawn)
- Weeds and wild grasses in rocks, landscaping, driveways, and easements
- Unkept backyard or backyard weeds seen from public view
- Lawn in need of mowing
- Unkept landscaping
- Bushes and shrubs not trimmed
- Dead trees and dead tree branches
- No tree
- Trees not trimmed
- Xeriscaping not maintained
- Mulch not in place or maintained
- Aging, unmaintained turf
- Dead or unmaintained flower beds

Unlike repetitious violations that sunset after six months, landscaping violations are considered continuous. That means they never expire but continuously carry over as

long as the owner lives on the property. For example, a property can receive consecutive violations for one or more of the above violations:

- Courtesy notification letter -Weeds in rocks
- Second violation \$75 fine Dead grass
- Third violation \$150 fine Weeds in rocks
- Consecutive violations \$150 fine Dead grass

These fines may be issued every 15 days after the property owner has received notification.

The violation that covers landscaping violations can be found in the <u>Cumberland Green Rules</u> <u>and Regulations, Landscaping Standards, page</u> <u>8: "Landscape Maintenance – All landscaping</u> <u>must be maintained in a neat, attractive, and</u> <u>healthy condition."</u>

The landscaping must remain manicured and attractive, and more specifically, the yard should be free from weeds and wild grasses growing in the rocks. This information is a lot to absorb, but feel free to contact me anytime with questions or concerns at <u>sarah@frommco.us</u>
